**Pallone for Congress**  
**Contribution Guidelines**

- Individuals are permitted to make contributions of up to \$2,400 for the primary and \$2,400 for the general election.
- A couple can make a contribution of up to \$4,800 for the primary and \$4,800 for the general election on a joint checking account provided both accountholders names appear on the check and/or both accountholders sign the check.
- Federal qualified multi-candidate PACs are permitted to make contributions up to \$5,000 for the primary and \$5,000 for the general election.
- Partnerships are permitted to make contributions up to \$2,400 for the primary and \$2,400 for the general election with partner attribution(s).
- Contributions from corporations, labor organizations, national banks, federal government contractors and foreign nationals are prohibited.
- Anonymous contributions are prohibited.
- Cash contributions may not exceed \$100 in the aggregate.

**Corporation.** Corporations are not allowed to contribute and any contribution cannot be accepted.

**Labor Organization.** Labor Organizations are not allowed to contribute and any contribution cannot be accepted.

- Federal law prohibits Pallone for Congress from accepting contributions from corporations, labor organizations, national banks and federal government contractors.
- Federal law prohibits Pallone for Congress from accepting contributions from foreign nationals. Individuals who have permanent U.S. residency (green cards) may contribute, however.
- It is illegal to reimburse any individual for a contribution to Pallone for Congress. It is illegal to receive a reimbursement for any contribution to Pallone for Congress.
- All materials soliciting funds for the Pallone for Congress campaign must contain the following statement: "Paid for by the **person paying for the solicitation** & Authorized by Pallone for Congress. Contributions to Pallone for Congress are not tax deductible. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and employer information for individuals who contribute in excess of \$200 in an election cycle."
- It is prohibited to use corporate stationery to solicit funds for Pallone for Congress.
- All solicitation materials, including invitations, must be approved before distribution by Pallone for Congress.
- Any expense made on behalf of Pallone for Congress is considered an in-kind contribution and counts against the donor's overall contribution limit. Please forward documentation detailing any expenses so that Pallone for Congress can report the expense as an in-kind contribution. The maximum in-kind contribution from an individual or partnership is \$2,400 for the primary and \$2,400 for the general election.
